I/we, _____ (the ADOPTER[s]), do this _____ day of _____, 20_____ enter into this Placement Contract with Neuse River Golden Retriever Rescue Inc. (hereinafter referred to as "NRGRR") of the dog named and described above. The ADOPTER(s) agrees to pay a placement fee of \$ _____ for this dog (see Section 16) pursuant to the terms of this contract which are set forth below.

Terms and Conditions: (after carefully reviewing each term and provision ADOPTER(S) should initial each point)

1. _____ ADOPTER agrees to provide this dog with a safe, loving, home environment, proper care and humane treatment in accordance with all current and future state, county and local laws and ordinances where ADOPTER resides. ADOPTER shall maintain identification by way of tags attached to a collar at all times and the collar must be on said dog at all times except when crated.
2. _____ NRGRR shall spay or neuter the dog (if applicable).
3. _____ ADOPTER understands that this dog has a microchip, and agrees not to take any action to have such microchip removed. NRGRR will be registered as the primary owner for the microchip and our veterinary partner as the primary veterinarian; ADOPTER will be registered as the secondary contact. ADOPTER agrees to immediately notify NRGRR if the dog is lost or stolen, and to make all reasonable efforts to find the dog.
4. _____ ADOPTER shall not sell, trade or dispose of said dog in any way, but shall return the dog to NRGRR if at any time the ADOPTER wishes to relinquish custody for any reason.
5. _____ ADOPTER shall not allow the dog to be used for any medical experiment or purpose whatsoever.
6. _____ ADOPTER shall not keep the dog chained, tied, or confined to an outside pen, nor shall the dog be trained for attack purposes or used for fighting purposes.
7. _____ ADOPTER shall not allow the dog to be free to roam the streets nor will ADOPTER transport the dog in the back of an open bed vehicle, such as a pick-up truck. In the event of multiple or repeated escapes by the dog, the owner shall be deemed to allow the dog to roam.
8. _____ The parties agree that no AKC or other registration is applicable to this transaction.
9. _____ ADOPTER agrees to allow representatives of NRGRR to visit Adopter's home upon reasonable notice to check on the overall wellbeing of this dog and to ensure compliance with the items set forth in this placement contract.

10. _____ ADOPTER understands and agrees that NRGRR shall have the right to remove this dog from ADOPTER'S home and care upon any misrepresentation in or breach of this placement contract. No full or partial refund of the fee shall be due in the event that NRGRR reclaims the dog from unsatisfactory conditions, and ADOPTER waives any right that he or she may have to challenge the transfer of possession under federal or state law.
11. _____ Both ADOPTER and NRGRR have a two week period from the time of ADOPTER first taking possession of the dog to rescind this placement contract for any reason. If the placement contract is rescinded within the first two weeks of possession, a full refund will be given to ADOPTER, and the dog will be returned to NRGRR. After the two week time period, if the dog is returned to NRGRR, ADOPTER's fee will not be refunded.
12. _____ The parties agree that the laws of North Carolina will govern the interpretation and enforcement of this placement contract, and both ADOPTER(S) and NRGRR hereby consent to the exclusive jurisdiction of Wake County for any state court matter or any federal court located within the state of North Carolina for the resolution of any dispute arising under this contract.
13. _____ ADOPTER(S) accepts this dog as is, assumes all risk of ownership, including the risk of injury or damage caused by the animal. NRGRR does not warrant the temperament or behavior of the rescue dog, nor is the rescue dog warranted to be free of genetic defects. The selection and adoption of the rescue dog is based upon ADOPTER's own observations and judgment, along with the foster home's observations while the dog was in foster care. ADOPTER(S) hereby releases, indemnifies, and holds harmless NRGRR, its officers, directors and agents from all liability of any type arising out of the placement of this dog by NRGRR.
14. _____ ADOPTER shall pay the adoption fee upon signing of this contract. If ADOPTER fails to make payment or if ADOPTER's check is returned for insufficient funds or any other reason, ADOPTER shall be responsible for all fees (specifically including attorney fees) and costs incurred by or on behalf of NRGRR resulting from such failure or return and any subsequent collection efforts.
15. _____ ADOPTER agrees that if ADOPTER fails to comply with any of the terms of the contract, NRGRR is entitled to any remedies that it may have at law or equity, including monetary damages, injunctive relief, and repossession on or after the date of this placement contract of the dog. ADOPTER agrees that he or she will be responsible for all reasonable costs and attorney fees resulting from any such legal action if NRGRR is successful therein.
16. _____ The following schedule sets forth the fee that will be applicable, based on the age of the dog:
